### ESCROW PROCESS FOR EARNEST MONEY DEPOSITS

### INITIATE THE PROCESS USING STEPS BELOW:

### **1. DELIVER DOCUMENTS**

### **OPTION 1:**

• Upload Purchase Contract and Escrow Agreement when completing Commercial Escrow Request located at <u>www.invtitle.com/commercial-escrow-request</u>.

### **OPTION 2:**

• Email the Commercial Escrow Request, Purchase Contract, and Escrow Agreement to <u>commercialescrow@invtitle.com</u>.

### **OPTION 3:**

• By overnight carrier, send the Commercial Escrow Request, Purchase Contract, and Escrow Agreement to Investors Title, Attn: Commercial Escrow, at the address below.

### 2. DELIVER FUNDS

All funds are placed in separate interest-bearing accounts. A W-9 will be required for this purpose.

### **OPTION 1:**

- Send funds electronically (up to \$100,000.00) through the secure "DEPOSIT ESCROW FUNDS" button on <a href="https://www.invtitle.com/escrow">https://www.invtitle.com/escrow</a>.
- You will receive immediate confirmation that the transaction was successfully completed and an official confirmation of receipt within one business day.

### **OPTION 2:**

- Wire funds. For wiring instructions contact the *Commercial Escrow Services team* at 800.326.4842 or <u>commercialescrow@invtitle.com</u>.
- You will receive confirmation of receipt within one business day.

### **OPTION 3:**

- Send the earnest money check by overnight carrier to Investors Title at the address below.
- · You will receive confirmation of receipt within one business day.

### **3. PREPARE FOR CLOSING**

When parties are ready to close, email preliminary Settlement Statement and wiring instructions to <u>commercialescrow@invtitle.com</u> at least 24 hours in advance.
