INVESTORS TITLE COMPANY BOARD INCREASES QUARTERLY DIVIDEND

CHAPEL HILL, NC – Investors Title Company announced today that the Company's Board of Directors declared a cash dividend of \$.40 per share to shareholders of record on September 1, 2017, payable September 15, 2017, a 14.3% increase per share over the \$.35 paid in the most recent quarter.

“The decision to increase the cash dividend over the prior quarter reflects the Board’s and management’s confidence in the Company’s strategy and ability to continue to generate sustainable cash flow,” said J. Allen Fine, Chairman of the Board of Investors Title Company.
